Confirmed isn't required by attendees.</p> <p>KHa (Acting chair) welcomed new attendees and asked all attendees to introduce themselves and also announced that SMa - Service Lead for Targeted and Specialist Inclusion at DCC will be the new chair for future Steering Group meetings.</p>

2.	<p>Minutes of last meeting – sign off and action update</p> <p>Confirmation, on request, that only initials will be published going forward. Minutes approved for publishing on Local Offer website</p> <p>Previous action: MTo mentioned an intention to launch an app for the Emotional Health and Wellbeing websites in June’s SG Meeting. Should the LO have involvement with this? Update: MFo will organise a meeting with MTo to discuss how this can be implemented.</p> <p>KHa to discuss with DPVC more opportunities for parents / carers to feed into the work of the website, such as previous DPCV Meet and Eat Events.</p>
3.	<p>Local Offer Annual Report 2023-2024 Sign Off</p> <p>Following the request and completion for additional information about what the next 12 months has in store for the Local Offer, the Annual Report will now be published, and will go to SEND Board for information.</p>
4.	<p>Workplan 2024/25</p> <p>4a. Review website and advisory panel and subsection leads – Updated</p> <p>Discussion about updated workplan.</p> <p>MFo offered to post on Public Health social media when actions 6 & 7 were completed.</p> <p>4b. DPCV SEND Survey Results</p> <p>VTh to provide a one-page summary update for the next meeting as this recently closed. Agenda Item for December 2024.</p> <p>4c. Local Offer Videos</p> <p>KHa advised this activity has started with ‘The Mighty Creatives’, alongside ‘Sparks Arts’ (Sparks Arts are a film school for children), creating an initial short explanatory video, about 30 seconds long, intended to be published on other websites (such as schools) to raise awareness and increase use. LCh is assisting in engagement of young people.</p> <p>4d. 10 Scenarios – Local Offer Functionality and Flow Investigation</p> <p>CPa fed back on a questionnaire which was provided to a group of professionals, who were allocated 1 of 10 common scenarios experienced by families. They were asked to audit the Local Offer website to find their scenario information and resources, whether content was accessible, ease of use and ease of understandability.</p> <p>Parents and carers were also asked to do the same activity with DPCV, but little feedback was submitted. A thematic analysis was actioned on the feedback that was received, which CPa will share with anyone who would like visibility. This then identified potential improvements that can be made to the website and content.</p>

5.	<p>Spectrum Autism Friendly Festival Participations and Children's Rights Attendance</p> <p>LCh shared a presentation: 'Participation does the Spectrum Festival'</p> <p>LCh – Spectrum is an autism friendly festival that runs annually at Lea Green Outdoor Education Centre in Derbyshire. This is the 4th time the Participation Team have attended. 800 people attend, most from Derbyshire/Derby City. It sells out annually.</p> <p>It is a good opportunity to showcase and promote the good work that we all do. If you can see the opportunities this event offers, and can use these opportunities in future SEND work, please consider talking to us so we can take this along next year.</p> <p>If you have leaflets, or promotional materials or anything we can use to engage with attendees, we would be more than happy to take these with us.</p> <p>VTh advised DPCV will also be attending Spectrum in 2025, and would like to discuss with LCh and DIASS.</p>
6.	<p>SEND Inspection Update</p> <p>JHo – It was a very thorough inspection. We want to thank anyone who was involved in any way, small or large. We await the results of the inspection, but expect some challenges ahead based on the findings in the report which is expected imminently.</p>
7a.	<p>For info only - 2024/25 workplan</p> <p>KHa – An update to TOR was completed.</p> <p>KHa – Content Ownership detailed to aid LO Admin to identify who has authority to suggest changes to content on specific sections of the website, or to review website content when applicable. This is routinely done every 6 months to ensure the page content is still up to date and accurate. Please advise as soon as possible if recent or future restructures have affected roles and responsibilities.</p> <p>RJo – There are required changes due to EYSEN, who are now part of EIS and not AAIS.</p>
